# **Processing Notes**

Collections are processed to a variety of levels, depending on the work necessary to make them usable, their perceived research value, the availability of staff, competing priorities, and whether or not further accruals are expected. The library attempts to provide a basic level of preservation and access for all collections, and does more extensive processing of higher priority collections as time and resources permit.

Upon initial accessioning of the collection in 1997, library staff placed the majority of oversize material into broadside folders and made no effort to arrange it. In 2014, library staff created lists of the oversize material as housed during accessioning, and minimally arranged other material.

# Gerald Fogarty Galloway (1886-1975)

Gerald "Jerry" Fogarty Galloway was born in Epping, England, son of a medical doctor Arthur Wilton Galloway (1849-1908) and Louisa Warde Fogarty Galloway (1851-1924). He immigrated to the United States in 1901, graduated from Colorado University in 1914, and subsequently taught at Rice University. In 1918, Galloway moved to Alma, Colorado, where he worked as an independent civil mining engineer, as well as a county surveyor and county supervisor for Park County. He also became active in several local mining ventures.

In his work, Galloway collected and maintained real property records for Park County created before he began his tenure as county surveyor. This includes the earliest records created by Lee Hayes (1844-1946), a mining engineer and United States deputy mineral surveyor established in the region circa 1880. In 1884, Hayes sold his business to engineers Hiram Phillips (1859-1921) and William H. Powless (1853-1949); the latter consequently served as county surveyor. During his tenure, Powless surveyed many of the region's roads and town plats represented in the collection, as well as established water rights in Park County. In 1919, Powless sold his business to Galloway, who likely acquired Hayes's and Powless's files at that time.

In 1917, Galloway married Mary "Molly" Montague (1896-1990), and they had a son, Gerald Fogarty Galloway, Jr. (born circa 1924).

# **Description of the Papers**

Material collected and created by Gerald F. Galloway including maps, field notes, correspondence, and other papers related to mining and the development of real property in Park County, Colorado, circa 1872-circa 1970. The bulk of material in the collection relates to gold, silver, lead, zinc, and uranium mines, as well as the companies responsible for mining operations. Personal papers related to Galloway in the collection include his schoolwork from the Colorado University and a correspondence course at Columbia University in the City of New York, as well as correspondence with friends and extended family members.
