Biographical / Historical

Colonel Frank Trumbull Lee (1856-1902) of Madison, Connecticut, worked in New Haven as a tobacconist in 1880; was secretary of the New Haven Carriage Company and a member of the firm of Leo & Osborn, machinists; was a real estate dealer; and was an officer of the Imperial Hygienic Fluid Company from 1895 to 1896.

From 1889 to 1893, Lee served with the Connecticut National Guard, New Haven Grays, Company F, Second Regiment.

He was briefly married to Virginia "Bessie" Scranton Lee, with whom he had a daughter, Marion Frances Lee. Following his divorce, Lee lived with his mother, Frances Maria Lewis Lee (1818-1902), and sister, Elizabeth B. Lee (1847-1924), in New Haven.

Scope and Contents

746 letters, bank deposit books, checkbooks, cash account books, a stock ledger book, receipts, circulars, brochures, prospectuses, documents, and ephemera by or relating to Colonel Frank Trumbull Lee, 1887-1901. Collection Contents

Series I: Correspondence, 1887 August-1901 February

Series I contains 746 letters, 27 telegrams, and 16 postcards to or from Colonel Frank Trumbull Lee.

A majority of the letters concern business dealings with bankers and stockbrokers, manufacturers, mining companies, and real estate developers over affairs in New Haven, Connecticut; Tallapoosa, Georgia; Kansas City, Missouri; Kearney, Nebraska; New York, New York; and other locations.

Other letters concern family matters in New Haven, as well as Lee's time serving in the Connecticut National Guard.

Series I is arranged into three subseries: Business, Connecticut National Guard, and Family and Acquaintances. Materials within each file are arranged in order received from dealer.
