Biographical / Historical

Frank Schilling Cummings (1894-1978) was an engineer and amateur anthropologist who grew up in Los Angeles, California, graduated Los Angeles Polytechnic High School in 1912, and settled in Oakland after attending college in New Jersey. In 1949, Cummings became acquainted with Frank Todacheene, a Navajo man. From this relationship, Frank Cummings and wife Betty Cummings photographed and recorded the traditions of the Navajo peoples near Monument Valley, Arizona, for more than two decades.
