SUMMARY: The Papers consist of speeches, correspondence, financial records,

photographs, scrapbooks and ephemera documenting the political life of George Clement Perkins. Speeches consist of manuscript versions in unidentified hands. Some speeches are identified within the folders; others are untitled and undated. The papers do not comprehensively document Perkins's official activities as a California legislator and governor, but focus on his political activity generally and his 1879 gubernatorial campaign. Some ephemera documents the activities of the Bohemian Club of San Francisco

circa 1880. Posthumous records document Perkins's estate.

George Clement Perkins, 1839-1923

George Clement Perkins was born in Kennebunkport, Maine in 1839 and died in Oakland, California in 1923. He began his career as a cabin boy on a merchant ship and quickly became successful in diverse entrepreneurial endeavors, including a steamship business. A Republican politician and businessman, he was a California State Senator (1869-1876), the 14th governor of California (1880-1883) and a United States Senator (1893-1915). He was married to Ruth A. Parker and they had several children.

Scope and Contents

The Papers consist of speeches, correspondence, financial records, photographs, scrapbooks and ephemera documenting the political life of George C. Perkins. Speeches consist of manuscript versions in unidentified hands. Some speeches are identified within the folders; others are untitled and undated. The papers do not comprehensively document Perkins's official activities as a California legislator and governor, but focus on his political activity generally and his 1879 gubernatorial campaign. Some ephemera documents the activities of the Bohemian Club of San Francisco circa 1880. Posthumous records document Perkins's estate.

Series II: Correspondence and Business Papers, 1862-1946

Series II consists of correspondence, financial records, invitations, and estate documents. Correspondence during Perkins's lifetime is fragmentary and relates chiefly to his social and political activity and to legal affairs, but does not comprehensively document his official duties as California legislator and governor. Correspondence and papers after 1923 relate chiefly to Perkins's estate. Financial records relate chiefly to the business of Goodall, Nelson & Perkins (later Goodall, Perkins & Co.).

Series IV consists of scrapbooks, clippings, printed ephemera, and sketches. Scrapbooks and clippings relate chiefly to Perkins's political campaigns and activity. Printed ephemera includes brochures and broadsides relating to Perkins. Sketches are pencil studies of shapes, signed "Perkins." Also included is a printed version of a speech by Charles E. Travers.
