SUMMARY: Collection of 51 letters sent to Rodney Mason from his brother Edwin Cooley Mason and mother Minerva Needham Mason, 1875-1878. The letters were sent as the pair travelled from Newport Barracks, Kentucky; Columbus Barracks, Ohio; Fort Vancouver, Washington; and Portland, Oregon, and document the Edwin Cooley Mason's service in the 21st Infantry Regiment of the Department of Columbia. A majority of the letters relate to the Nez Perce War and the Bannock War and mention generals Oliver Otis Howard and Nelson Miles among others, as well as Indigenous peoples including the Nez Percé (also known as *nimípuu*), Bannock, Coeur d'Alene (also known as Skitswish), Okanagan (also known as Syilx, Okanogan, or Okinagan), Palos (also known as Palouse), and Yakama. Letters dated 1877 chronicle the military service of Edwin Cooley Mason in Idaho, moving from Lapwai to Cow Island before returning to Fort Vancouver. These include mention of Chief Joseph (born *Hin-mah-too-yah-lat-kekt*), leader of the Wallowa (*wal-lam-wat-kain*) band of the Nez Perce Tribe, and others taken prisoner by Nelson Miles. A letter dated 1878 indicates the beginning of the Bannock War and references Chief Moses (born *Kwiltalahun*, later called *Sulk-stalk-scosum*), leader of the Sinkiuse-Columbia.

Biographical / Historical

Edwin Cooley Mason (1831-1898) of Springfield, Ohio, was the son of United States Congressman Samson Mason (1793-1869) and Minerva Needham Mason (1805-1890). His birth followed those of his brother Rodney Mason (1824-1893) and sister Emily Mason Haynes (1827-1848).

Edwin Cooley Mason served in the United States Army during the American Civil War and was brevetted Brigadier General, United States Volunteers on June 3, 1865. He later served in the United States Army in the Department of Columbia, 21st Infantry Regiment during the Modoc War (1872-1873), Nez Perce War (1877), and Bannock War (1878). He retired from the army in 1895. He was married to Frances Mary Kingsbury Mason (1844-1913), and they had four children: Kathro Montague Mason (1868-1930), Mary Needham Mason Moore (1870-1955), Frances Kingsbury Mason (1874-1907), and Charles Haynes Mason (1881-1951).

Rodney Mason served as a colonel in the United States Army during the American Civil War and resigned in August 1862. He became a patent attorney in Washington, D.C., and was married to Mary Alice Camp Mason (1844-1924).

Scope and Contents

Collection of 51 letters sent to Rodney Mason from his brother Edwin Cooley Mason and mother Minerva Needham Mason, 1875-1878. The letters were sent as the pair travelled from Newport Barracks, Kentucky; Columbus Barracks, Ohio; Fort Vancouver, Washington; and Portland, Oregon, and document the Edwin Cooley Mason's service in the 21st Infantry Regiment of the Department of Columbia.
