Edmunds from Downieville, California to his family in Michigan concerning his life in California, the Universalist faith, his work as a missionary preacher to Gold Rush miners, and the temperance movement. With three letters to Cynthia Edmunds from unidentified friends, a poem entitled "My Sister's Grave," and unidentified manuscript poems and speeches.	1852-1860
b. 1, f. 2	Field, Edward G. Autograph letters, signed, from Sacramento, California, to Field's sister, commenting on raising hogs during the Gold Rush and the high level of immigration to California.	1852-1854
b. 1, f. 3	Field, Henry B. Autograph letters, signed, from San Francisco to a "Mr. Merriman." The letters concern Field's efforts to sell newspapers, become a merchant, and work as a miner. Field gives lengthy descriptions of the process of mining and the life of miners.	1850
b. 1, f. 4	Fox, Peren V. Autograph letters, signed, from Mariposa, California to Fox's wife Ida, and a letter to Fox from an E. Leland regarding Leland's employment.	1853-1855

Letters concern mining, lumber, an 1860 massacre at Carson Valley of white people by Native Americans, and Indian rain dances.	1859-1861

b. 1, f. 36	McLellan, Josiah Autograph letter, signed, from Murphy's Camp, California, to McLellan's sisters in Maine, with news about people they know living in California.	1854 October 29

b. 1, f. 20	Morrison, John H. Autograph letters, signed, from Rio de Janeiro and San Francisco to Morrison's family regarding his stay in Rio de Janeiro and his voyage to California via Cape Horn, as well as the population explosion and high cost of living in San Francisco.	1849-1850

b. 1, f. 22	Pond, Benjamin Franklin Autograph letters, signed, from San Francisco and Greenwood Ranch, California to Pond's parents regarding mob law, violence, and vigilance committees during the Gold Rush, as well as family matters and expenses.	1847-1853
b. 1, f. 23	Scranton, Joel G. Autograph letters, signed, from Sacramento to Scranton's brother regarding gold, crops, "yellow boys," and a flood.	1852

b. 1, f. 30	Unidentified Letters from unidentified authors from San Francisco, Panama, New York, and Peoria on a variety of subjects, including mining, a voyage through Panama from New York to San Francisco, a description of the city of San Francisco, and Mormons. Also includes a letter on Levi pictorial letterhead advertising denim pants to miners.	1849-1850
