Processing Information

Biographical / Historical

Richard Wright was born in Liverpool, England, in 1794, the son of John Wright, a Unitarian lay preacher. Seeking to escape religious persecution, the Wright family emigrated from Liverpool to Georgetown, Washington in 1817. The family corresponded with Peter Robinson and others in Liverpool; their letters contain impressions of Georgetown, Washington, D. C., and Alexandria, Virginia, as well as extensive writing about their Abolistionist views. Richard Wright died in 1870.

Scope and Contents

This collection contains correspondence between Richard Wright and Hannah Wright and Peter Robinson, with related correspondence between members of the Robinson family and others. It also includes writings by Richard Wright, as well as correspondence and legal documents relating to Joseph Johnson Robinson.

Arrangement

This collection is organized into two series: I: Wright family, 1817 - 1889. II: Robinson, Joseph Johnson, 1814 - 1907.
