### Processing Information

Collections are processed to a variety of levels, depending on the work necessary to make them usable, their perceived research value, the availability of staff, and competing priorities. The library attempts to provide a basic level of preservation and access for all collections as they are acquired, and does more extensive processing of higher priority collections as time and resources permit.

The collection is comprised of material formerly classed as: Uncat MSS 433, Uncat MSS 635, Uncat MSS 1027.

The collection received preliminary processing at the time of acquisition. Further rehousing, and description were carried out in 2014. Various acquisitions associated with the collection have not been merged and organized as a whole. Each acquisition is described separately in the contents list below, titled according to month and year of acquisition.

Information included in the Description of Papers note and Collection Contents section is drawn from information supplied with the collection and from an initial survey of the contents. Folder titles appearing in the contents list below are often based on those provided by the creator or previous custodian. Titles have not been verified against the contents of the folders in all cases. Otherwise, folder titles are supplied by staff during initial processing.

Researchers should note that material within each acquisition overlaps with and/or relates to material found in other acquisitions. In order to locate all relevant material within this collection, researchers will need to consult each acquisition described in the Collection Contents section. Researchers should also note that similar material can be arranged differently in each acquisition, depending on how the material was organized when it was received by the library.

This finding aid may be updated periodically to account for new acquisitions to the collection and/or revisions in arrangement and description.

## **Doris Bry**

Doris Bry (1920-2014) was a scholar of Alfred Stieglitz, and was Georgia O'Keeffe's business agent and confidant. She is the author of *Alfred Stieglitz: Photographer* (1965), and editor or co-editor of *Some Memories of Drawings* (by Georgia O'Keeffe, 1974), *Georgia O'Keeffe, in the West* (1989), and *Georgia O'Keeffe: The New York Years* (1991).

## **Scope and Contents**

The collection consists of correspondence, publication material, art work, printed material, photographs, and other papers relating to Doris Bry's various editorial projects and professional association with Georgia O'Keeffe.
