The records include crime reports, crime statistics, policies, correspondence, annual reports, arrests and incident reports concerning matters dealt with by the Police Advisory Board. Materials in these files are primarily addressed to Richard Carroll, Chair of Police Board, Henry Chauncey, Jr., Special Assistant to the President and Chair Police Board, and Jonathan Fanton.
