The first voyage was May 4 - Aug 13, 1789; the next began Jan 21, 1791, and thereafter voyages continued regularly until June 15, 1792. Cargoes consisted of beef, corn, peas, rice, pork, molasses, naval stores, lumber salt, flax, wine and other items, with an occasional passenger. b. 2, f. 1reel 1U	<p><i>York</i> (U.S. schooner) of Boston, Mass. Cmdr. Francis Burch, master. "The journal of the armed schooner, with a crew of one hundred and nine, mounting ten long nines and four twelve pound cornades." On a cruise from Boston in chase of English ships, the <i>York</i> captured four brigs which were sent back to the United States as prizes and two ships, of which one was set afire and one taken as a prize.</p> <p>This material has been microfilmed. b. 2, f. 2reel 1U	<p><i>Panther</i> (Ship) of Boston, Mass. Captain William Austin, commander. Journal kept by Austin on a voyage from Boston "toward the Columbia River." Sailing from Boston, they rounded Cape Horn on July 20, 1820, and put in at Callao for trade on August 13, taking on a cargo of tin, cotton, and a small amount of vicuna wool. There they were caught in a blockade in consequence of the War of Independence, and remained until November 20 when they left in a convoy. The journal reports the events of this period in detail. Arriving at Samanco on Nov 25, 1820, the captain found "that two days before the People of Vepena, a small village 6 Leagues in the interior, had declared in favor of the Patriots and were pursuing the most conducive steps toward revolutionizing the whole country and my own interest not being effected [?] by these events and being a friend to rational Liberty, I could not but congratulate a people who long oppressed have at length attempted to throw off the yoke of foreigners and to govern themselves."</p> <p>This material has been microfilmed. b. 2, f. 2reel 1U	<p>They arrived at Paita (Peru) on December 1 where they took on a cargo of cotton and 25 passengers. On the return journey, they rounded the Cape again on January 7, 1821, with their destination Gibraltar (Venezuela). The journal breaks off four days after they pass the Island of Fernando de Naronha off the Brazilian coast.</p> <p>This material has been microfilmed. b. 2, f. 3reel 1U	<p><i>Nile</i> (Bark) of Boston, Mass. Charles O. Gragg, commander. From St. Iagoes [Cuba?] towards Genoa with a cargo of sugar and coffee. The journal begins at St. Iagoes. They arrived in Genoa on May 24, 1838, and left on June 15, returning to Boston by way of Leghorn, and arriving August 31.</p> <p>This material has been microfilmed. b. 2, f. 4reel 1U	<p>Cynthia(Bark) "Journal of a voyage from Salem to Canton in the Barque Cynthia commanded by Emery Johnson of Salem, begun in 1838 and terminated 1840. Kept by Charles Upton of Salem." The journal, which is incomplete, begins with the departure from Salem and ends on the return voyage from Manila to New York. The entries are almost entirely on weather, wind, the management of the ship, notes on the ship's diet, with occasional reference to passing ships.</p> <p>This material has been microfilmed. b. 2, f. 4reel 1U	<p>The volume was later used as a scrapbook. Clippings have been removed, but traces of newsprint and glue are still visible. It was also used as a notebook, possibly by Emory T. A brief entry on August 12 when the brig put in at Valpariso records that the writer resigned his commission, but being unable to secure passage in any other ship, continued on the brig to San Francisco as a passenger. The journal ends with an "Abstract Journal" from October 3 to Oct 19, 1852 when the ship was within two degrees of latitude of San Francisco.</p> <p>This material has been microfilmed. The final entries are for his voyage in 1884 [as captain?] on the brig Salisbury to Rio de Janeiro with accounts for the ship.</p> <p>This material has been microfilmed.
