## Biographical / Historical

Jonathan Barnett was born on January 6, 1937, in Boston, Massachusetts. He received a B.A. from Yale College in 1958, where he was a Scholar of the House in Architecture; an M.A. from Cambridge University in 1960; and a M. Arch. from Yale in 1963. Following graduation, he worked for the firm of Smith, Haines, Lundberg and Waehler and designed several university buildings. In 1964 he became associate editor of the *Architectural Record* magazine. In 1965 he was an advisor to the John Lindsay mayoral campaign and in 1967 helped start the Urban Design Group at the New York City Planning Department, which he directed from 1969 – 1971. As a consultant in urban design and development, Barnett advises cities throughout the United States; private investors; and government agencies, such as the National Park Service and the New York State Urban Development Corporation. From 2002 to 2008, Barnett worked with Wallace Roberts and Todd, and continued, until 2010, as an independent consultant on projects in Cambodia and Korea.

He was professor of architecture and director of the Graduate Program in Urban Design at the City College of New York and then professor of Practice in City and Regional Planning and director of the Urban Design Program at the University of Pennsylvania. Barnett is the author of numerous articles and books on city planning and urban design.

The material consists of writings, lectures, reports, teaching materials, notebooks and calendars documenting Barnett's research, teaching and consulting career.

It contains record copies of reports produced in professional practice as an independent consultant, Jonathan Barnett FAIA, FAICP, as well as work with Wallace Roberts and Todd. The box includes memos to the managing partners about Barnett's work. The series also includes documentation of the research studio at the University of Pennsylvania, funded by governments or other organizations looking for advice for real situations, with reports equivalent to the reports of a consulting study. Each folder contains the studio syllabus and the report prepared by the graduate students with advice from JB, other faculty and outside experts. Also included is a report prepared by Barnett's graduate students at the City College of New York in 1994. Barnette's published writings and presentations from 1958 to 2016 and notebooks are included in the series.

Projects in the series are also documented in earlier series in the collection.
