Biographical / Historical

Franklin MacVeagh was born on November 22, 1837, in West Chester, Pennsylvania. He received his B.A. from Yale in 1862. MacVeagh studied at Columbia University Law School (1862-64) and received his LL.B. in 1864. Although selected valedictorian of his law school class, a breakdown in health prevented his appearance in that role.

MacVeagh joined with Charlton T. Lewis (Yale, 1853) to form Lewis & MacVeagh, a New York City law firm. Again poor health required his withdrawal from service. He served with the Pennsylvania Militia for a time during the Civil War.

After a respite in Minnesota to alleviate health problems MacVeagh settled in Chicago, Illinois. He established the firm of Franklin MacVeagh & Company, wholesale grocers, in 1866. MacVeagh served as president of the firm from 1866-1909 and 1915-1932. An active public life in Chicago included service as first president of the Citizens Association of Chicago (1874), president of the Chicago Bureau of Charities (1896-1904), vice-president of the Civil Service Reform League of Chicago (1884-85) and the American Civic Association (1905), trustee of the University of Chicago (1901-13), member of the executive committee of the National Civic Federation, and chairman of the First International Congress of Social Insurance (1914). In addition, MacVeagh was also involved with the Municipal Art League and the Chicago Yale Association (1881-82).

In 1894 MacVeagh was nominated by the Democratic State Convention of Illinois for the office of U. S. Senator, but he was defeated in the general election. By 1896 MacVeagh had joined the Republican Party and later served the nation as secretary of the treasury (1909-13) in the administration of President William Howard Taft.

MacVeagh married Emily Sherrill Eames on October 2, 1866. They had five children. Franklin MacVeagh died July 16, 1934, in Chicago, Illinois.

Scope and Contents

The papers of Franklin MacVeagh consist of correspondence from the years 1861-1925. Bulk dates for the approximately one hundred items contained here are 1910-1925. The papers are arranged in one box and measure two and one-half inches of material.

The correspondence is entirely routine in nature and focuses almost entirely upon matters pertaining to Yale University. MacVeagh's political activity in Chicago and later in Washington, D.C. as secretary of the treasury (1909-13), is virtually entirely ignored in this material. Rather, the subjects of these letters include a variety of alumni and ceremonial matters relating to MacVeagh and the class of 1862. The great quantity of correspondence consists of incoming letters, with only randomly scattered carbon copies of outgoing letters present.

Among the individual correspondents included in the papers are: James H. Crosby, William W. Farnam, William H. Hale, William Kent, and Cornelius Ladd Kitchel. Crosby, as secretary for the Yale class of 1862, contacted MacVeagh for financial and informational contributions to Yale funds and publications. Letters from Farnam, Hale, and Kent are examples of the courtesies extended to a successful alumni by fellow Yale men. Correspondence with C. L. Kitchell involves the usual discussion of alumni activities. A 1904 letter, however, urges MacVeagh to contribute financially to the Yale-in-China movement.

Several other manuscript collections contain the correspondence of Franklin MacVeagh. The Charles Dewey Hilles Papers (Mss. Gr. 281) contains over two hundred letters relating to MacVeagh's service as secretary of the treasury. For additional materials the following collections should be consulted: William Kent Family Papers (Mss. Gr. 309), Samuel R. Betts Autograph Collection (Mss. Gr. 548), and the Chauncey Mitchell DePew Papers (Mss. Gr. 180).
