## Collection Contents

### Original accession

#### Part I

1400-1768

Part I is 4.5 linear feet; the majority is comprised of both originals and copies of materials from Spain. The collection includes state documents such as decrees, ordinances and reports; ecclesiastical texts; correspondence; accounts of events; political writings; and literary texts. They cover a broad period of Spanish history, from the beginning of the fifteenth century to the middle of the eighteenth century. The texts document important events and aspects of the reigns of Philip III, Philip IV, Philip V, Ferdinand VI and Charles III.

On the reign of King Philip III (1598-1621), the collection includes letters by the Duke of Lerma, the powerful private secretary (*privado*) to the king; documents related to state loans; and memorials. Memorials constitute outstanding sources for studying the political, social and economic conditions of the Spanish monarchy in the two first decades of the seventeenth century. Although a long tradition of writing memorials existed in Spain, Philip III's reign was particularly rich in the composition of such texts. They addressed such issues as the origin of the "decadence" of Spain, and important political and economic problems and their solutions. There are also texts on the conduct of foreign policy by Antonio Pérez; royal policy towards Portuguese "conversos" by Martín González de Cellorigo; and the duties of the king's private secretary (*privado*) by Pedro Maldonado. The education of the young King Phillip III was an important issue during his reign. The "Empresas," by Juan de Mora, a book written to instruct the king on moral and political principles necessary for ruling, is beautifully illustrated with numerous drawings and is a splendid example of Spanish emblematic literature.

Documents on the reign of King Philip IV (1621-1665) are the most numerous of the collection. The main political and social events of that period, including the death of King Philip III; the political downfall of three major figures of the reign of King Philip III: the duke of Lerma, the duke of Osuna, and the marquis of Siete Iglesias; the ceremonies proclaiming Philip IV of Spain; the political career of the duke of Olivares, the private secretary (*privado*) of the king; the plan for a matrimonial alliance between Spain and England; the economic efforts of the Spanish crown to finance its participation in the Thirty Years War; the Castilian monetary reforms; the Spanish intervention in the Netherlands war; and the political relations between the Spanish crown and its Italian allies in Milan, are described in handwritten and printed texts.

Important aspects of the history of the reigns of three Bourbon monarchs, Philip V (1700-1746), Ferdinand VI (1746-1759) and Charles III (1759-1788) are also documented in the collection. With no direct descendants, King Charles II named Philip, Duke of Anjou, a grandson of King Louis XIV of France, as his successor. The election of a French prince was not recognized by other European states, which had potential candidates of their own for the Spanish throne and were concerned about the expansion of French power on the continent. The war of the Spanish Succession and the efforts of Philip to consolidate his rule are illustrated in an extensive account of the period from 1712 to 1725, entitled "History of the reign of King Philip V of Spain," and in other documents. Once the war was concluded, Philip started an ambitious program to reform the social, political and economic structures of the Spanish monarchy. The so-called "Bourbon Reforms" encouraged crown ministers and other citizens to develop and write projects and plans to encourage the social and economic development of Spain and its empire. Interesting examples of such writings are: "España despierta" and "Nuevo sistema de gobierno económico para la América," by José del Campillo y Cosío, a famous minister of Philip V.

## Part I (continued)

The Bourbon Reforms were continued by Philip V's successors, Ferdinand VI and Charles III. Additional informative examples of reform plans and projects, from the reign of Ferdinand VI, include "Reflexiones ...sobre los medios que se pueden tomar para el fomento de fábricas de todas especies y del comercio interno y externo de España" by Juan Casaus, and "Proyecto...para fomento del comercio, agricultura y fábricas de estos reinos" by Francisco Pavia. There are also various documents on tax reform during Ferdinand's reign, and on the relationship between the Inquisition and local powers. Of particular note regarding Charles III's reign (1759-1788) is "Aniceto a Cándido," a discourse on the need to reform Spain; and an extensive "Memorial," addressed to the king, on the long controversy between the Society of Jesus and prelates and secular clergy over the payment of tithes. In addition, there are documents on the crown's attempt to exercise tight control over the Spanish Catholic Church.

Needing funds for the war against Portugal, the king had given his treasurer, Juan de Herrera, lordship over Balmaceda. In turn, Herrera had paid 15,000 florins to the king. In this grant, Henry III granted 7,500 florins to Balmaceda to be used by the village in its attempt to buy out Herrera. This volume contains an original and copies (in English) of texts by Agustín de Sotomayor: "Benefícios de metales de plata" (handwritten and signed by author), "Translation of extracts from Noticia histórica documentada de las célebres minas de Guadalcanal," and "A Letter from Augustin de Sotomayor to his majesty upon the method to be followed in the discovery of mines and the manner of working them."	1555-1573

b. 3, f. 28reel 2U	Title: "Verdadera relación." Place: Seville. Description: Printed account of the ceremony in Madrid proclaiming Philip IV king of Spain, and the funeral held in memory of Philip III, at the Church of Saint Jerome in Madrid.	1621
b. 3, f. 29reel 2U	Title: "Relación de avisos." Place: Seville. Description: Seventeenth-century printed texts containing news (avisos) on politics, wars and social events are considered to be early forms of journalism. b. 3, f. 47reel 2U	Title: Report to the king. Place: Granada. Description: This report is addressed to the king and aimed to serve as a guide for the conduct of Spanish foreign policy. The text has two parts: the first explains the reasons why some European and Asian nations were against the Spanish monarchy; the second, provides advice on political alliances and economic measures to be taken during the Thirty Years War.	1625 March 29

Part II is 1.5 linear feet; the majority is comprised of originals and copies of materials from Spain. The collection includes state documents such as decrees, ordinances, wills and reports; ecclesiastical texts; church documents; correspondence; accounts of events; political writings; and literary texts. They cover a broad period of Spanish history, from the beginning of the sixteenth until the end of the nineteenth century. The majority of documents date to the

period of the monarchs of the Bourbon dynasty: Philip V (1700-1746), Ferdinand VI (1746-1759), Charles III (1759-1788), and Charles IV (1788-1808).

Because King Charles II named a member of France's House of Bourbon, Philip, the duke of Anjou and a grandson of Louis XIV, as his successor, the French became deeply involved in Spanish affairs. This is best documented by a report on the conduct of the princess of Ursino in Spain, who came to dominate the royal court in the early years of the reign of Philip V (1700-1746).

The "Bourbon Reforms" were aimed at encouraging the social and economic development of Spain and her colonies. Most useful for the study of the reforms is a report by Francisco Cabarrus dealing with the need to grant the Banco de San Carlos a monopoly on silver extraction. There are materials by Manuel José de Ayala, a distinguished jurist, who sought to modernize and publish Spanish laws governing the Indies. They include an index to numerous volumes of Ayala's materials which show what he considered important to his legal thinking. Finally, there is a report urging the establishment of a new royal trading company for the Indies so that Spain, rather than other foreign powers, would profit from the Iberian empire.

The reign of Charles III (1759-1788) witnessed the beginning of the "Age of Revolution" when England's North American colonies fought for their independence. A report (1783) examining the threat that the newly independent United States posed to Spain's colonies sheds light on the impact of this event on Spain.

The reign of Charles IV (1788-1808) witnessed the French Revolution and its subsequent events, which culminated in the invasion of Spain by the forces of Napoleon in 1808. Several manuscripts capture the turbulence of the era, including a letter from the Spanish ambassador in Paris describing the state of Franco-Spanish relations; an appeal by Gaspar de Jovellanos, a dominant figure of the Spanish enlightenment, for justice after his imprisonment on Majorca; a report dealing with the Spanish defeat at the Battle of Trafalgar; and a denunciation of the French invasion by Pascual Solono y Noboa.

The Napoleonic invasion of Iberia led to the beginnings of independence movements in Spain's Latin American colonies. Spain's struggle to maintain its empire is documented in a series of reports discussing foreign trade in the Americas and seeking the re-establishment of the system of "comercio libre," as it had functioned prior to the wars; plans for the reconquest of the colonies detailing the means by which Spain could achieve this feat; and a diplomatic note from the American minister to Spain urging the king to accept the loss of the American colonies. In addition, a series of orders from the king of Spain addressed to the count of Cartagena detail the restoration of the "liberal" order in 1820.
