Trustee of the Village of Batavia, N.Y., 1902-1903; Justice of the Peace of the Town of Batavia, 1904-1907; District Attorney of the County of Genesee, N.Y., 1908-1916; City historian of the City of Batavia, 1919-); City attorney of the City of Batavia; New York State Attorney for the Tonawanda Nation of the Seneca Indians, 1908-1916 and 1928-1939.

#### Scope and Contents

These papers pertain to a lawsuit brought in 1951 by chiefs of the Seneca Nation living on the Tonawanda Indian Reservation in New York State to remove Mrs. Carrie Blueye from the reservation as an intruder, since her mother was Tuscarora and not Seneca. They are the papers of William H. Coon, a retired attorney and former district attorney of Genesee County. Coon was acting as an adviser to the current district attorney, Wallace J. Stakel, who was the prosecuting attorney in the case. Included is correspondence exchanged between Coon and Stakel providing background information on the case, memoranda concerning suggestions for the district attorney's brief, trial memoranda and briefs, and newspaper clippings about the case.
