Blaisdell family

Consists of 109 items. 52 autograph letters signed from Hiram Blaisdell to his wife, Betsy, regarding his military life and services as a private in Battery A, 3rd New York Artillery; also 49 autograph letters signed from Betsy to Hiram concerning conditions at home [Martville, Cayuga County, New York]; also 8 autograph letters signed from various other members of the Blaisdell family, including William and Melino Blaisdell (Hiram's brothers), Celenda Hancock (Betsy's aunt), Lydia T. Beebe (Hiram's aunt), Roxanna Blaisdell (Hiram's sister), and Milo D. Eldridge (relation unknown).

Hiram Blaisdell entered the 3rd New York Artillery at Auburn, New York, in September 1864; a month later he was sent to New Bern, North Carolina, where he remained almost the whole of his one year term of enlistment. An unusually homesick soldier, Hiram filled his letters with poignant regrets that he could not

be at his wife's side and with much sober advice on how she was to conduct their farm during his absence. Aside from complaining of the hardships and dullness of camp life, Hiram made few observations on the war, except to anticipate a rapid peace and his return home. He does, however, give some news as to the number of rebels deserting to the Union lines.

The dull routine of camp life is broken twice--in February (1865), Hiram went on a raid and the following month (March) he participated in the hotly contested battle at Kinston, North Carolina. [Note: he gives a very good description of the effectiveness of artillery against the Confederates.] Shortly after the Battle of Kinston, Hiram succumbs to diarrhea and spends the rest of his enlistment in the LeNoir General Hospital.

Betsy's letters give a very detailed picture of life for those back home in Martville, Cayuga County, New York. She describes the hardships and loneliness of a childless wife on an isolated farm; the terrible snowstorms of upstate New York; the lack of funds and difficulty of bringing in crops; lack of help from neighbors, etc.

	Arthur B. Carpenter served as a sergeant and later as an officer in the Union Army, 19th Infantry Regiment during the Civil War. The letters, mainly to his parents in Monson, Massachusetts, give war news, battle descriptions, comments on army life and politics, camp routine, civilians with whom he came in contact, military leaders, politics, religion, Negro emancipation, and details of the contemporary scene, as well as descriptions of the countryside through which he passed.

James, Edward Christopher (1841-1901)

The papers of Colonel Edward Christopher James consist chiefly of 107 letters written during the period August 22, 1861, to August 5, 1863, while he was with the 106th Volunteers of New York. The letters are addressed to his mother, Lucia Ripley James (1819-1901), and to his father, Amaziah Bailey James (1812-1883), in Ogdensburg, New York. The remainder of the collection includes memorabilia and photographs of family and prominent Civil War figures, many of which were taken by M. S. Brady.

Colonel James served as acting-assistant adjutant-general of the engineer brigade of the New York 50th Volunteers during the winter of 1861-1862 and during the Peninsular Campaign (1862) was aide-de-camp on the staff of General Daniel P. Woodbury, commanding the engineering brigade in the Army of the Potomac. James made an extremely rapid rise in rank from adjutant in 1861 at the age of 20 to the rank of colonel in 1862 at the age of 21. Many of the letters deal with the trials and tribulations of command for so young an officer. Along with reflections on home, honor, and duty, the letters provide a valuable insight into Union Army life as experienced by a most impressionable young man.

Parmelee, Henry Spencer (1843-1902)

Henry Spencer Parmelee was the son of Spencer Thomas Parmelee, a New Haven merchant and president of the Fair Haven and Westville Horse Railroad, which was the first street railroad in New Haven. He entered the service as a member of Company B of the 1st Connecticut Cavalry on September 8, 1862, in Bridgeport, Connecticut, and was stationed at Fort Trumbull in New London, Connecticut, for several weeks before being sent to the Baltimore and Washington, DC, areas. He served as an orderly for General Henry S. Briggs of the Army of the Potomac for some time and lost his right hand at the Battle of Sayler's Creek, Virginia.

The correspondence consists of approximately 180 letters between Parmelee and members of his family in New Haven. Much of this correspondence is fairly routine, describing the details of camp and army life and family and social news from home. It would appear from the correspondence that Parmelee did not see much battle action himself, although there is some information on the death of his brother Lewis at Antietam. There is also some correspondence from others who were not members of the family, notably, a few letters from General Briggs.
