### **Biographical / Historical**

Patricia McGowan Wald was born in Torrington, Connecticut in 1928. She received a BA degree from Connecticut College in 1948 and an LLB from the Yale Law School in 1951. From 1951 to 1952, Wald served as a law clerk to Judge Jerome Frank and from 1952 to 1953 was an associate in the firm Arnold, Fortas and Porter. During the 1960s, Wald held several conference and commission positions studying crime, violence, civil disorder, criminal justice, and law and poverty. She also served as an attorney with the Neighborhood Legal Services Program and the Center for Law and Social Policy in Washington, D.C. and was co-chair of the Ford Foundation Drug Abuse Research Project. From 1972 to 1977, Wald was an attorney for the Mental Health Law project, and she served as the Project's litigation director from 1975 to 1977. Wald was the assistant attorney general for legislative affairs in the Department of Justice from 1977 to 1979. She was appointed circuit judge for the United States Court of Appeals for the District of Columbia Circuit in 1979 and served as its chief judge from 1986 to 1991. Wald served on the United Nations' International Criminal Tribunal for the Former Yugoslavia from 1999 to 2002, on the President's Commission on Intelligence Capabilities of the United States Regarding Weapons of Mass Destruction from 2004 to 2005, and the Privacy and Civil Liberties Oversight Board from 2012 to 2017. Wald died in Washington, D.C. on January 12, 2019.
