## Biographical / Historical

Jacob "Jay" Katz was born on October 20, 1922, in Zwickau, Germany, where his father was a business owner. When Adolph Hitler and the Nazi Party came to power in 1933, Katz's family's German citizenship was revoked. His father arranged for him to obtain a Czech passport, and at age sixteen, Katz traveled alone to Prague, and ultimately to the United States by way of Italy and Great Britain. The rest of his family joined him in the United States in 1940.

Katz graduated from the University of Vermont in 1944, and in 1949 he earned his medical degree from Harvard Medical School. Following his education, Dr. Katz completed his internship and residency in New York City, and then enlisted in the United States Air Force, serving as a First Lieutenant and Captain at the Maxwell Air Force Base hospital in Montgomery, Alabama.

Katz's career at Yale University began in 1953 when he was appointed Chief Resident at the Yale School of Medicine's outpatient clinic. He began teaching psychiatry at Yale in 1955, and in 1958 was named Assistant Professor of Psychiatry and Law at Yale. Dr. Katz's work in the areas of medical law and bioethics began when he served on a committee that drafted the Connecticut law that established the terms of patient privilege for psychotherapists and their patients in 1961. This law served as a model for the Federal Rules of Evidence, which are enforced across the United States.

In 1972, Katz was named to serve on a federal committee charged to investigate the Tuskegee Syphilis Experiment, begun in 1932 to study the progression and effects of untreated syphilis in about 400 impoverished African-American men from rural Alabama. The infected men were never told that they had syphilis, and were never treated for it, though they were compensated for their participation in the study with free health care, meals, and burial insurance. The committee concluded that the experiment was unethical, that the participants should have been treated for their infections, and called for greater governmental oversight and protection of subjects in medical studies.

In 1994, Katz was appointed to serve on the Advisory Committee on Human Radiation Experiments, charged by President Bill Clinton to investigate 30 experiments in which individuals were unknowingly exposed to radiation. Katz was active on a number of other bioethics issues, as an outspoken proponent of the concept of informed consent, and as an opponent of the use of data gathered during Nazi medical experiments.

Katz was the prolific author of six books and numerous articles, and wrote extensively on topics related to the relationship between medicine, ethics, and law. He died on November 17, 2008, at the age of eighty-six at his home in New Haven, Connecticut.

## Scope and Contents

The collection comprises the papers of medical doctor, Yale Law School professor, and bioethicist Jay Katz. The papers document Katz's significant contributions to the field of bioethics, through both his teaching and scholarship, and through his public service and advocacy as a member of two federal committees charged to investigate human medical experiments. # Collection Contents

## Series I: Correspondence, 1961-2003

This series comprises a small assortment of both incoming and outgoing correspondence that primarily concerns Katz’s scholarship, writings, and speaking engagements. It includes extensive correspondence from the 1960s and 1970s with Anna Freud, a notable figure in the field of child psychology and the daughter of Sigmund Freud. Anna Freud was a visiting lecturer at Yale Law School during the period documented in the correspondence.

## Series II: Federal investigation files, 1939-1997

This series comprises Katz's papers from his service on the Advisory Committee on Radiation Experiments and the Tuskegee Syphilis Ad Hoc Advisory Panel. The papers from the Advisory Committee on Radiation Experiments consist of memoranda and subject files. The majority of the memoranda were written and distributed to Katz and other members of the Advisory Committee by the committee's staff or in some cases, fellow committee members. The memos provide valuable insight into the committee's investigative process, particularly the ethical framework that it developed through which to analyze the experiments in question. The memos also richly document the drafting of the committee's final report, and include drafts and revisions of sections of the report, and comments on the drafts made by committee members. The remainder of the memoranda concern many of the radiation experiments that the committee investigated, including the nuclear weapons tests at the Marshall Islands during the 1940s and 1950s; the Nuclear Energy for the Propulsion of Aircraft (NEPA) project; human plutonium injection experiments at the Oak Ridge National Laboratory during the 1940s; and Operation Paperclip, which involved the recruitment of German scientists to work for the U.S. government following World War II. Many of these memos are accompanied by copies of relevant historical documents, and/or summary reports compiled by committee staff members.

The subject files from the Advisory Committee on Radiation Experiments consist mostly of copies of historical documents concerning the radiation experiments investigated by the committee. These include declassified government documents, meeting minutes, interview transcriptions, and reports. The subject files provide further documentation of the committee's investigation of the NEPA project and the Marshall Islands nuclear weapons tests, and also document investigations into other radiation experiments, including the Operation Teapot nuclear weapons tests of 1955; and medical radiation experiments performed on subjects at the Arctic Aeromedical Laboratory in Alaska, at the Medical College of Virginia, and at Vanderbilt University during the 1940s and 1950s.

The papers from Katz's tenure on the Tuskegee Syphilis Study Ad Hoc Advisory Panel consist of correspondence, copies of historical documents related to the experiment, articles and press clippings documenting the panel's work, and administrative documents pertaining to the panel's investigation. The correspondence includes both incoming and outgoing correspondence, primarily between Katz and other members of the panel. The historical documents consist mostly of copies of correspondence between doctors who participated in the Tuskegee Syphilis Study, as well as copies of periodic reports on the status of the experiment. These materials span the entire course of the experiment, from the 1930s to the early 1970s, with the bulk of the historical documents dating from the 1930s. Administrative records of the advisory panel include a copy of its final report, copies of internal memos, and transcriptions of the proceedings of the panel's meetings.
