## Biographical / Historical

Dori Laub was born in Czernowitz, Romania, in 1937. A survivor of the Nazi Holocaust, Laub emigrated to Israel in 1950 where he attended medical school. Dr. Laub became a psychiatrist and psychoanalyst, emigrated to the United States, and settled in New Haven, Connecticut, where he was an affiliate of Yale New Haven Hospital. Beginning in 1979, Dr. Laub collaborated with Laurel Vlock to videotape Holocaust survivor testimony, which led to the founding of the Holocaust Survivors Film Project and subsequently the Fortunoff Video Archive for Holocaust Testimonies. Laub died on June 23, 2018, in Woodbridge, Connecticut.

## Scope and Contents

The collection consists of interviews conducted by Dr. Dori Laub, of Holocaust survivors who were psychiatric patients at the Beer Yaakov Hospital in Israel. Included are video recordings of each interview in the native language of each interviewee, a one-page index of interviews, and transcriptions in English for most of the interviews. Some of the interviews were recorded using both PAL and NTSC standards.
