Materials related to *Evans v. Romer* include correspondence, court documents, and publications either immediately from the case or from

Ramsay MacMullen is the Dunham Professor Emeritus of History and Classics at Yale University. He received the American Historical Association Award for Scholarly Distinction in 2000. He has published sixteen books as of 2011.
