Processing Information

Collections are processed to a variety of levels, depending on the work necessary to make them usable, their perceived research value, the availability of staff, competing priorities, and whether or not further accruals are expected. The library attempts to provide a basic level of preservation and access for all collections as they are acquired, and does more extensive processing of higher priority collections as time and resources permit.

This collection received a basic level of processing, including rehousing and minimal organization.

Folder titles appearing in the contents list below are often based on those provided by the creator or previous custodian. Samuel Adams Green

Samuel Adams Green (1940-2011) was an American art curator closely associated with the pop art movement, especially Andy Warhol, whose first retrospective was hosted by Green at the Institute for

Contemporary Art, Philadelphia, in 1965. Green's active role in the art world ended by 1970, after which time he cultivated a career as a socialite, befriending and occasionally serving as an assistant to celebrities including Cecil Beaton, Greta Garbo, John Lennon, and Yoko Ono.
